With due respect, I have the honour to state that on 19/03/2024 at @ 10.00 AM, some unknown persons who came in two cars i.e one Hyundai Creta white in colour without registration number and one Fiat Punto car yellow color B/Regn No. MN01G 0722 have forcibly kidnapped my younger brother namely Khoirom Sanjoy Singh (34 yrs) from our residential gate located at Lalambung Makhong Khoirom Leikai, Imphal. Later on, on the same day I received a phone call from my brother's phone number 9863555056 and he told me that he was beaten up mercilessly by the unknown persons and released him at Heingang Awang Leikai, Imphal East. Immediately, I along with my family members rushed at the spot and when we reached there, we found that my younger brother was brutally assaulted by the unknown persons and he was evacuated to RIMS hospital for medical treatment. On reaching at RIMS hospital, my brother narrated the whole story. He told that he was brutally assaulted by the unknown armed miscreants by using some deadly weapons at gunpoint. The unknown armed miscreants also made a video of his confessional statement of raping a girl namely Dolly of Lalambung Makhong, Imphal who was in relationship with him few years ago. Now, the health condition of my brother became deteriorated and complicated due to the injury received from the brutal attacked by the unknown armed miscreants and he is now referred to Shija Hospital, Langol for further medical treatment.

It, is therefore, requested your good self to kindly find out the unknown armed miscreants who came on the above mentioned cars at the earliest and to take up necessary legal action.
