

Subject: Request for taking up necessary action and to provide a security protection round the clock.

Sir,

I the undersigned lay down some few lines for your kind necessary action in the matter hereunder;

I am a registered Special Class Contractor, PWD:Manipur and also President of United Social Development Association, registered body under Society Act. I execute contract works under the State Government and Central Govt. projects and its undertaking authority as well as I run Children Home for Boys, under the Social Welfare Dept. Govt. of Manipur in my residence at Sagolband Meino Leirak, Imphal.

I have filed one complaint dated 16/02/2024 before the Lokayukta, Manipur against the members of the Tender Committee of the notice inviting Bid No. CE/NH/BID2023-24/01, dated 13/04/2023 for the work "Strengthening of road from Km 459.930 to Km 465.200 of NH-02 under NH Division in State of Manipur for the year 2022-23 on EPC mode" under the PWD:Manipur. The said complaint was registered as Complaint Case No.3 of 2024 and thereby appointed an investigating officer for investigating matter.

Subsequently on 5 (five) consecutive days i.e. from 20/03/2024 till today, some unknown persons have visited by house cum Children Home and threaten me to withdraw the above noted complaint case No.3 of 2024 with dare consequences. And as a token of their threat they have opened fire at my Hot Mix BT Plant situated at Phumlou, near Mahajon Golai on 24/03/2024 at around 11.45pm. As such my life, the life of my family members, life of my staffs, labours and the life of the inmates of the Children Home are not safe.

Therefore, from the above facts and circumstances, I am earnestly requesting you to kindly take necessary action and to provide a security protection to save our lives.
