



That, one M. Kartik, aged about 29 years, S/o Muniya Sami of 62 Annai Sivagami Nagar 2nd Street, Ennore Chennai Kaltivakam, Tiruvallur, Endore Thermal Station, Tamil Nadu, 600057 presently residing at the 3rd Floor, Hotel Daani Continental situated at Thangmeiband Meisnam Leikai who is the Proprietor of "Imphal Kangla Cab Service" had taken my vehicle Nissan Kicks, Grey in colour bearing Regn. No. NL07CB-3970 having Engine No. H5HA460D063341 & Chassis No. MDHFCAD15M7001121 registered in the name of K. Lungningdaipou 45 yrs S/o Kamei Khumdailung of Sunrise Burma Camp, Dimapur, Nagaland for using his cab service on the 14th November, 2023 with a condition to pay a sum of Rs. 40,000/- (Rupees Forty thousand) only per month as hiring charge. Surprisingly, it is learnt that he has mortgaged my said vehicle to an unknown individual whose residence is still not known. He has now absconded from his present residence and office. Vigorous efforts have been made to trace him and my vehicle but in vain. Thus, he has cheated me and misappropriated my vehicle for his wrongful gain only. The handing taking of my vehicle was made at the premise of Daani Continental, Thangmeiband Meisnam Leikai.

It is therefore, requested kindly to recover my vehicle and take up necessary legal action against him as per law.
