Today i.e. 31/03/2024 at 06.30 PM, I came across a viral note in one letter head of Arambai Tenggol vide Ref No. 2647/GHQ/AT/2024 dated 30/03/2024 signed by Laishram Robason, Control Room Operator, Arambai Tenggol in social media that "this is general information from Arambai Tenggol to the general public of Manipur that during the ongoing crisis in Manipur no one is allowed for election campaign, grand feast, using loud speaker, flag hoisting, street corner meeting in c/w the upcoming Lok Sabha Election. This will only lead to the disintegration our society and to create enmity among ourselves. But the general public can cast their vote of their own choice without disturbing to anyone. However, the general public is strictly restricted from election campaign, grand feast, using loud speaker, flag hoisting, street corner meeting in c/w the upcoming Lok Sabha Election". Moreover, the self-styled commander of Arambai Tenggol namely Korounganba Khuman also posted in his face book post that "Arambai Tenggol will ban the election campaign of the upcoming Lok Sabha Election as it will create chaos as well as bloodshed since fire arms are abundant in the state."

The viral note of Arambai Tenggol and the Facebook post of Korounganba Khuman directly interferes the candidate's or voter's right thereby restraining the general public from free & fair and peaceful practice of election. Moreover, transmitting such message provokes the general public and creates enmity between different groups thereby likely to disturb the maintenance of harmony, public order and public tranquillity in the state.

Hence, a suo-mottu case under FIR No. 216(03)2024 IPS U/s 120-B/153-A/171-F IPC has been registered against Korounganba Khuman and others for investigation.
