

Jagatchandra Singh of Thangmeiband Yumnam Leikai who is now out of station. As my elder brother A. Robot Singh is now out of station, they warned to come at their camp located at Langol, Imphal either me or my elder brother without giving any specific reason.

It is therefore, requested kindly to look into the matter and take up necessary action against the unknown armed miscreants as per law.
