

Kuki nupi na AR camp ta changbaduga eikhoi gi hanubi singna babupara da lakpaga karidabu khetnarigeyne sudhir sahib 2. Hanubi khara yonthokchari. Manipur da thamfam leitrey. Only Rs 500. 3. Rs 500 da Manipur yonbi thunubi sa. 4. Babupara da hanjin hanjin lakeba hanubi sing se yum gi mi singna amukta warakpiyu. Yam ekai etc.

The viral face book post directly insults and intimidates the old aged woman folks as a whole with intent to outrage their modesty. The viral post also induces the general public, and provokes to create enmity between different groups thereby likely to disturb the maintenance of peace and harmony, public order and tranquillity in the state.

Hence, a suo-mottu case under FIR No. 225(04)2024 IPS U/s 153-A/505(2)/354/500/506/509/120-B IPC has been registered for Investigation.
