Subject :- Report on criminal intimidation and Unlawful displacement.

Madam

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Elizabeth Mangneilhing** aged about 22 years D/o **Khamkhogin Touthang** Belonging to the Any-Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am staying at Hostel working womens Hostel at Paona bazar, P.S- Imphal Police station, Imphal west - 795001
2. That at about **10am** on the **4th May 2023**, Due to the Ethnic conflict prevalent in the state ,the Meitei mob trying to harm and attack any Kuki-Zo people residing in Imphal valley ,I have to run for my life and took shelter at **1st MR(Manipur Rifle) Camp**. And in the process I left behind all my belongings.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and the belongings which I have left behind is estimated to be **Rs. 15000 (Rupees Fifteen Thousand) only**
4. Fortunately, I managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at **B.Aizalon Village Churachandpur** .
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at **B. Aizalon Village Churachandpur**. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
