

Sir,

With due regards, I beg to state that today i.e. 20/03/2024 at about 05:30 am received a reliable information that some unknown miscreants have stored some arms, ammunitions and explosives at Phungrei Ching under the jurisdiction of NSK-PS.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with COB Somrei, 33 AR 'D' COY led by OC/CDO-TBL and OC/NSK-PS under the Supervision of Shri H. Devendra Singh, MPS, Addl. SP(Ops)/TBL and under the overall Supervision of Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 06:15 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 01 (one) No. of 5.56 mm INSAS Rifle bearing registration No. 18245317 along with magazine (2) 05 (five) Nos. 5.56 mm INSAS live rounds ammunitions, (3) 02 (two) Nos. of 36 HE Hand Grenade (can be used as explosive), (4) 01 (one) No. of Tube Launcher, (5) 02 (two) Nos. of WP GREN No. 80 MK-1, (6) 01 No. of Tear Smoke Shell (CS), (7) 01 (one) No. of Tear Smoke Shell Soft Nose, (8) 01(one) No. of Stun Shell Normal, (9) 02 (two) Nos. of Cartridge 38 mm Anti-Riot with Rubber Bullet, (10) 01 (one) No. of Detonator & (11) 01(one) No. of Combat Helmet have been seized from the spot at 07:20 am. The massive searched Operation was conducted from 06:15 am and continue till 08:00 am of the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
