



SUBJECT: APPREHENSION OF SUSPECTED ARMS DEALER MR NGANINGMI VASHUM

Respected Sir,

1. Based on credible input from our own source, a joint operation with representatives from Ukhrul Police Station was launched in Viewland, Ukhrul to search the residence of Mr Nganinmi Vashum resident of New Tusom village. The operation was undertaken with effect from 2200 hours on 09 April 2024 and was culminated at 0005 hours on 10 April 2024. On searching the residence and the premises, the following items were seized from the above mentioned individual:-

- (a) Cash : 13,11,130/- (Thirteen Lakh Eleven Thousand One Hundred Thirty rupees only).
- (b) One 9mm Carbine Machine Gun and one magazine.
- (c) 9mm ball ammunition: 37 live rounds.
- (d) One Pistol with magazine.
- (e) One Chinese Hand grenade.
- (f) 5.56 mm INSAS ammunition: 40 live rounds.
- (g) 0.22 mm ammunition : 15 live rounds.
- (h) 7.62 AK- 47 ammunition : 01 live round.
- (i) 7.62 SLR Fired cartridges: 03.
- (k) Assault Rifle Sling: 03.
- (l) One 12 Gauge Shotgun.
- (m) Shotgun ammunition : 110 live rounds.
- (n) Shotgun Fired Cartridges : 03.
- (o) Mobile Phone- 02
- (p) Wallet- 01.

2. The individual has not been harassed in any manner during the conduct of the operations. You are requested to take suitable action at your end at the earliest.
