FIRST INFORMATION REPORT(FIR)

I, Shri Thongkhoinlen Haokip, an employee of SBI would like to lay the following few lines for your kind consideration and favour please.

02. That, I have a homestead land along with RCC building(G+3) at 2nd Street, New Lambulane, New Checkon, Imphal, Manipur-795005 near SBI ATM and opposite to the Covenant English School bearing Dag no -2243, Patta No-991/1583(old), 246(New). I have been staying at the above mentioned house with my family from 2nd Nov'2007. I & my family had to leave the house on 04th May'2023 due to the ongoing ethnic violence that engulfed Manipur since the 3rd May'2023 as there was no other option, it was a matter of life and death.

03. After we left, the locality/ house was guarded by the Army/Para Military forces. Now, my house has been looted by miscreants on 26th February, and it has been unlawfully occupied since then, defying the Supreme Court order dated 07/08/2023. The house is still intact till date. However, all my assets inside the house has been looted.

04. I, therefore, earnestly request you to kindly take measure in your power to protect my assets and property (ies) as per the law of the Land.
