I have the honour to report that on 27/03/2024 at around 10:00 am, one Md. Ziulhaque aged about 40 yrs. s/o late Md. Gaffer of Hatta Golapati stabbed my elder brother namely Md. Yashin Moinam aged about 26 yrs. s/o Md. Rahimuddin of Hatta Minuthong by holding a knife(dao) while he came down from his house stair located at Hatta Minuthong where the said culprit already awaited there. Accordingly nearby public gathered to stop the incident however Md Ziulhaque escaped from the spot on taking advantage of crowd. As a result of which, Md. Yashin Moinam sustained serious injuries on his persons and evacuated to the Public Hospital, Hatta for medical treatment.

It is, therefore, requested to kindly take up necessary legal action against the culprit as soon as possible.
