Sir,

Most respectfully, I the undersigned would like to state a few lines to bring your kind notice and further necessary action.

That, on 30/01/2024 at around 1:55 pm a heavy shoot-out took place between the village volunteers of Meitei and Kuki at the hill ranges of Nakhujang village and Kharam Thadoi Village and lasted till 4:00 PM in which two Meitei volunteers who were later identified as 1) Meishnam Khaba @ Ibomcha (25) s/o M. Hemanta of Sagoltongba Mamang Leikai, Imphal West and 2) Nongthombam Michel Singh (32) s/o (L) N. Imo Singh of Konung Leikai Palace Compound, Imphal East were killed in the said shoot out. Further some meitei volunteers sustained bullet injuries and evacuated to Hospital for medical treatment but the details of the injured persons could not be ascertained as of now. The two dead bodies were deposited at RIMS Morgue.

In this regard, I request you to kindly take up necessary legal action regarding the matter.
