With due respect and great humble to your honour. We would like to inform you that on dated 24/12/2023 approx 14:00 PM our vehicle bearing registration number MN04P2196 was intercepted at a location near Koubru Leikha Mandir few unknown person around 10 in numbers, who claimed to be K.N.F. (D). The vehicle along with all VRLA Battery 48v, 600AH – 24 nos were forcibly taken away by the unknown persons, left driver and labour accompanying the driver at the spot. Again, on dated 27.12.2023 around 12:45 PM, the mentioned vehicle is found in Haipi Village in Kangpokpi district. But unfortunately all the VRLA Battery 48v, 600AH – 24 nos were found missing. The above mentioned VRLA battery 48v, 600AH – 24 nos was meant to be installed to a 5G tower located at Hengbung village, Senapati district of Manipur.
