That, due to the on-going conflict, we were compelled to flee our home located at my residential home at Kangchup Chingkhong, PO Lamsang, PS Gamnom Sapormeina on the 1st of August, 2023 around 3:30 pm as it was attacked by unknown miscreants.

Unfortunately, it is also learnt from reliable sources that all my household properties were ransacked, plundered and looted by unknown miscreants believed to be volunteers of Arambai Tenggol and Meitei Leepun on the 1st of August, 2023.

The estimated value of the properties lost, damaged or looted is about Rs. 20,00,000/- (Rupees TwentyLakhs)

In this regard. I would like to request your good office to take up necessary action so that I can be compensated, the culprits be caught and stringent exemplary punishment be meted upon them.
