3.That the above said criminals with their in humane activities have causes me grave mental agony. Notwithstanding the fact that, there unruly activities have made me great loss enormous wealth estimated to be Rs 5 lakhs 50k

4. Fortunatrly, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at CFC Relief Camp Churachandpur.

So,I could not make the said report on time due to the present situation which unable me to do the report.

I, therefore, request you to register on FIR and bring justice.
