

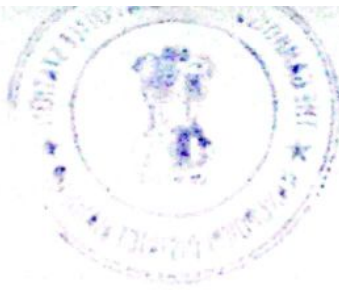

Today i.e 16/9/2022 at 10:00 Pm, Received information that some volunteers of BJYM(Bharatya Janata Yuva Morcha), numbering about 20(twenty) went to Damdei-Leikot area to conduct Anti Narcotic drive. At about 3:00 Pm, the volunteers were fired upon by some unknown persons. After the firing stopped the volunteers came across one person who sustained bullet injuries on his left leg lying on the ground near orphan cemetery. The person was later identified as Mangminsei Kipgen(27) S/O Paosat Kipgen of Leikot Village, Kangpokpi District, Manipur .The team checked and found one soap case(green in colour) containing 13.94 gram of brown sugar (without soap case), 2 nos. of mobile phone-Realme RMX3085(silver colour) and Realme(Blue colour) from one purple and blue waist pouch worn by the injured person. The injured person was evacuated to hospital for medical treatment .The volunteers on further search found one country made pistol with magazine and 3(three) live rounds among the bush near where the injured person had fallen. The recovered bag containing the illicit drug and mobile phones and the country made pistol with magazine and 3(three) live rounds were handed over to the police by the BJYM volunteers.

Hence ,a suo-motu case under FIR NO. 17(9)2022 G-SPM-PS u/s 21(b) ND&PS Act & 25(1-C)A.Act. has been registered for investigation.
