

Subject; Complain against State President and its executive of BJYM for arbitrarily shooting a civilian Mr. Mangminsei Kipgen on his left leg and injuring him for allegedly carrying some contraband tablets.

Sir,

With due respect it is to make complaint at your good office against the unlawful and arbitrary action of the president and its executive of BJYM on the following few points:

1. That, on 16/09/2022 at around 4:30 PM at Kanglatombi Orphanage near War Cemetery (AH-2), my son was chased and stopped by the executive of BJYM and they have shot my son on his left leg, injuring then and there on the allegation of carrying some contraband tablets (only 1 or 2 strip)
2. That, the president led executive of the BJYM came in 3(three) vehicle and have committed the ultra vires act which is illegal and strongly condemnable.
3. That, on 17.09.2022 the BJYM had flashed in the News that my son was carrying an arm (Pistol) as well which is totally false and implanted by them because my son doesn't have the capacity to buy one and also he has no nexus with any arms group/gang.

In the above given facts and circumstances your good office in requested to take prompt and strong action against the president led executive of BJYM who have accompanied for committed gross ultra vires action which is illegal and called for Departmental Enquiry against the erring officials who are with them when incident occurred.
