

With due respect, I have the honour to state that on 21-10-2022 at about 2:30 pm, my sister-in-law namely Phul Maya Tamang aged about 37 years W/O Ram Bahadur Singdan Tamang of Nine Miles Poudel Basti, Irang Part-I, P.O & P.S-Kangpokpi, Kangpokpi District, Manipur while coming from Imphal fall down from the bus bearing Regn. No. MN08T-0084 at Mongpijang village along NH-2. She was rushed to Raj Medicity, Imphal for medical treatment but after thorough investigation. Doctor could not save her and declared dead. I could not report the matter in time due to attending for her medical treatment.
