Sir,

With due respect, I would like to state the following for your kind information and necessary action :-

That, due to the on-going conflict, we were compelled to flee our home located at my land at Kangchup Chingkhong Village, PO Lamsang, PS Lamsang, Saitu Gamphazol Sub-Division, Kangpokpi District, Manipur, on the 4th of May, 2023 around 9 AM.

Unfortunately, it is also learnt from a reliable sources that all my household properties were ransacked, plundered and looted.

The total cost of properties lost, including all household items, poultry farm and many other valuable properties is estimated to be about Rs. 30,00,000 (Rupees Thirty Lakhs)

In this regard, I would like to request your good office to take up necessary action so that I can be compensated, the culprits be caught and stringent exemplary punishment be meted upon them.
