

With reference to the above cited Subject, I have the honor to report to you as below:

1. That, I Haokholun Vaiphei Age: 53 S/O S. Pathang Vaiphei belongs to KUKI Community, a scheduled Tribe recognized under the constitution of India. Whereby, I am a permanent resident of Nakhujang Village P.S: Gamnom Sapormeina, District: Kangpokpi.

2. That on 2nd June 2023 at 4 pm, a huge contingent of Armed radical/Meitei, Arambai Tengol and Meitei Iepun attack our village and in the process looted/Vandalized and burnt our houses and properties.

3. That the above said criminals with there in humane activities have caused me grave mental agony. Notwithstanding the fact that, there unruly activities have made me great loss enormous wealth estimated to be Rs 24 Lakhs 40K.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at Mata IFCD Relief Camp, Churachandpur.

So, I could not make the said report on time due to the present situation which unable me to do the report.

I, therefore, request you to register on FIR and bring justice.
