That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.16,00,000/- (Rupees Sixteen Lakhs) Only, inclusive of my house and the household items/ movable assets.

That, the reason behind my late application is due to which I was at different remote areas, and I humbly pray you to kindly regioster a ZERO FIR, and booked the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
