

I am a scheduled tribe belonging to the Vaiphei Tribe, which is a recognized tribe under the Constitution of India and a permanent resident of Nakhujang Village, Kharam Vaiphei, P.O./P.S-Lamsang & district-Kangpokpi, Manipur.

That, on the 4th of June, 2023 at around 4:30 PM, a group of Meetei / Meitei miscreants suspected to be members of Arambai Tenggol and the locals in and around the area attacked our village and in the process they have vandalized, looted and arson attacked my house along with my household items/movable properties.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.16,00,000/- (Rupees Sixteen Lakhs) Only, inclusive of my house and the household items/ movable assets.

That, the reason behind my late application is due to which I was at different remote areas, and I humbly pray you to kindly register a ZERO FIR, and booked the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
