Subject: Complaint against Kangchup Chiru Residents.

Sir/Madam,

In inviting a reference to the above subject, I would like to bring to your kind attention that Kangchup Chiru Reserve Forest was notified a Reserve Forest by order of H.H in council Memo No.6966-8(C) dated. 24/04/1948. As a part of the state's Government's effort to survey and consolidate the boundaries of Protected areas of the state, show cause and eviction notice were served following due procedure of the law. The encroachers were give ample time to voluntarily remove all structures inside the reserved Forest failing which an eviction drive was to be conducted.

In view of the above stated facts, an Eviction drive was carried out by a combined force of Forest Department at Kangchup Chiru Reserved Forest on the afternoon of 6th December 2022. Inspite of all attempts to carry out the eviction peacefully, the resident of Kangchup Chiru resorted to violent attempts like stone pelting and catapulting to prevent the officials and staffs. During the altercation, Forest guard and police personnel were injured. Therefore, the officials had to use necessary force to carry out the eviction drive.

In this regard, it is requested, it is requested that an FIR be filed under relevant sections of the Indian Penal code against the perpetrators. Show cause notices, Preliminary offence Report and Eviction Notices are enclosed for your kind perusal.


