They looted all valuables and set ablaze to ashes. The approximate value of lost and destroyed are to be about Rs. 11,00,000/ (Rupees eleven lakh forty seven thousand) only. And including veterinary Hospital Furniture worth Rs. 47,000/- (Rupees Forty seven Thousand) only.
