**Subject: Report of Kangchup Chingkhong Jr. High School burnt properties by Meitei Leepun and ArangbamTengol**

Sir,

I, have the honour to state that, on 4<sup>th</sup> may, 2023 at around 11:30 AM some Meitei miscreants belonging to Meitei Leepun and Arangbam Tengol who had been carrying sophisticated weapons like AK rifles, 303 rifles, Pistol, Motor etc, with vehicles forcefully entered in my village located at kangchup chingkhong, kangpokpi District. They looted all valuables and set ablaze to ashes. The approximate value of lost and destroyed are to be about Rs. 16,56,000/ (Rupees sixteenth lakh fifty six thousand) only. And including school Furniture worth Rs. 1,09,000/- (Rupees one lakh ninethousand ) only.

I, therefore request to kindly registered a regular case and take necessary legal action according to law. I am herewith enclosed the list of assets Lost.
