Sir,

With due respect, I have the honour to report that poppy destruction was carried out at the south eastern hill range of Langka village under Kangpokpi District for 2(two) days from 5th to 6th March, 2024 by a joint team of District Police, Kangpokpi, 22 AR Banglabung post, Langka village authority led by Inspt. B.Lunthang Vaiphei assisted by Self, S.I Khailet of R/L, ASI Lienkhohao Khongsai of KP-PS including Executive Magistrate, Kangpokpi and staff under the supervision of SP-KPI, in which illegal Poppy Plantation of about 25(twenty five) acres were destroyed. The approximate value of the destroyed of Poppy is Rs. 1,50,00,000/-(Rupees one crore, fifty lakhs only).

I therefore request you to take necessary legal action in this regard.


