With due respect, I undersigned Smt. Thokchom Reena Devi (51) W/o Ahanthem Bubonchandra Singh of Chingmeirong Lei Hingkhoh, Project Director of Drop in Center (DIC) Charhajare near Namthang ground (MS Goma Devi Saw Mill), Kangpokpi District, Manipur have the honour the following few line for further necessary action.

That, our Drop in Center (DIC) under Manipur State AIDS control Society was open in a rented building own by Mrs. Goma Devi Nepal (64) W/O Kadernat Nepal of Charhajare near Namthang ground, Kangpokpi District, Manipur from the last 14 years. Due to the present ethnic violence we didn't went to our office from the beginning of the riots i.e 03/05/2023. On 02/01/2024 at around 2 pm the owner of the building namely Mrs. Goma Devi Nepal informed through telephonic that on 4/5/2023 at about 2:00 am all the properties of the said office i.e all valuable documents, one computer set, furnitures set, furniture items, Clinic materials were taken out and totally burnt down by the kuki rioters. The approximate value of the properties that were burnt down is about Rs. 2,50,000/- approximately (Rupees Two lakhs fifty thousand only).

Regarding the matter we couldn't able to report to the concern police station i.e G-Sapermeina Police Station till date due to the present situation in the state.

It is therefore, requested you to kindly look into the matter and take up necessary legal action.
