

With due respect, I have the honour to state the following few lines that, I have running 2 wheeler vehicle workshop at Leimakhong bazar, due to the ethnic violence I along with my family member have left workshop cum home on 03/05/2023 at around 7:35 pm and taking shelter at Mandop Yumpham, Fabricated house. It come to light that today i.e 11/03/2024 at around 7:30 am 2 (two) wheeler vehicles i.e. one Suzuki Swish bearing Regd. No MN01C-8041 having Engine No. F4862244303, Chassis no. MB8CFCBBD8165372 and one Honda Activa bearing Regd. No MN01C-3154 having engine no. JF50E70063119, Chassis no. ME4JF501BD7063044 along with some Rectangular pipe (estimate about RS 2,07,000/-) and 2 H.P. Air compressor were stolen away by some unknown persons. The approximate value of looted properties are estimated at Rs. 5,74,000/- (Five lakhs seventy-four thousand only) approximately.

Regarding the matters I could't able to report to the concern PS i.e. Gamnom Sapormeina PS due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is, therefore, requested you to kindly take up necessary legal action against unknown culprit.
