Sub: Theft case of Automatic Water Level Recorder Station under National Hydrology Project at the river's mouth of the Singda Dam water body was stolen by unknown miscreant.

Sir,

With due respect, I would like to state that under National Hydrology Project our Astra Microwave Products Ltd. has been doing civil works, installation and site maintenance of Automatic Rain gauge Station, Automatic Weather Station and Automatic Water Level Recorder at 33 sites co-operated with Manipur – Water Resource Department.

On 14th March 2024 at our site visit, we found out that one no. battery, one no. solar plate, and one no. power supply connector approximate value of Rs. 35,000 has been stolen and dismantled the iron fencing portion at the river's mouth of the Singda dam water body, Kangpokpi District which is at the North-West side of the dam approx.. 4/5km from the dam spillway. And the co-ordinates of the station also mentioned below-
