

Sir,

With due respect and humble submission, my name is Lamshi Hangshing (37) yrs and I am native of Kangchup chingkhong Village in Manipur. In lodging this complaint against Arambai Tenggol for attempted murder, looting and burning of my house, properties inclusive of all valuable documents, materials belonging to Kangchup Hill Branch Post Office. These various crime have left me in a trauma and unsafe in our own state of Manipur.

On dated 4/5/2023 at 11:00 AM, my house was subjected to a horrific act of vandalism where miscreants led by Arambai Tenggol broke into my property and looted all of our valuable possessions. These miscreants came to attack me and my family with deadly weapons like iron rods, knives and also by holding arms. The perpetrators set fire to my house and vandalize kangchup Hills Branch Post Office causing extensive damage and rendering it inhabitable. This has not only caused financial loss, but also emotional trauma for me and my family and the loss will not be able to recover for the rest of my life. Now, I am left with nothing as a had to run for my life and had a narrow escape from death. This horrible incident has had a profound impact on our life and we feel violated and unsafe in our homes.

I, urge you to take swift action to bring this criminal to justice. Therefore I requested to kindly register the case and take necessary action according to law.
