Most humbly and respecfully, I would like to bring to your attention that our village KangchupTwikun was under attacked by mobs numbering around 500 members led by black shirt wearing Arambai Tenggol and burnt down our entire village houses on 5th may, 2023 at around 4:00 pm. Fortunately, my grocery store was not included in those burnt houses by the attacker but all my properties and shop items were destroyed and looted by the suspected Arambai Tenggol. So. I would like to lodge FIR on 13/01/2024 and could not report on time as I was expecting to return back to my village. We fled for our life leaving our village and temporarily styaing at ITI Relief Camp, Kangpokpi. My destroyed house and stolen properties worth is Rs. 5,00,000/- (Five Lakhs Only).

I, therefore kindly request to take up necessary legal action to arrest the culprit involved in looting and destroying of my properties.
