Sir,

In Inviting reference to the above subject matter, I have the honour to report you that there is a report of Theft on 10/01/2024 at around 8:40 pm by unknown miscreants from Heavy fuel Base plant (HFBPP), Leimakhong MSPCL as per reported.

The generator power plant campus consist of old heavy machineries and its accessories, Besides this, this there is an active switchyard which consist of electrical equipments like transformers, current transformers, Potential transformers, circuit breakers, control & Relay panel, conductors, others accessories and oil reservoirs (Furnace Oil, High Speed Diesel oil and light diesel oil).

Further it is also mentioned that, the theft and burglary of heavy oil (furnace Oil, High speed diesel, Light Diesel Oil) Spillage has been observed in and around the locality of Heavy fuel Based power plant at Leimakhong and surrounding area by our staff. The incessant flow of oil in the river stream has a great environmental hazard in and around the region. It is reported that the people of the region is likely to get problem of water due to the contamination of river water.

It is, therefore, requested to kindly take up immediate necessary action in the interest of the Public and Power Department a well.
