I the undersigned beg to report for your kind and necessary action.

That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

That, on 02/06/2023 at around 5;00pm a number of unknown miscreants numbering about 200/300 mobs suspected to be ArambaiTengol and Meetei/MeiteisLeepun attacked our village including my residential house at Nakhujang Village. (near Kangchup) Kangpokpi district, under sapermeina police station.

The said unknown armed miscreant also set on fire and burned down my residential house, including my household properties and other house hold items. The total Approximate loss of my properties is about Rs 30,00,000/- (Thirty Lakhs only).

Delay of filling a FIR is due to displacement and uncertainty of relief camp/place.

In view of the facts and circumstances, I shall be very grateful if your good self would kindly initiate appropriate steps for identifying the unknown arms miscreant, apprehend them and punished them in accordance with law.
