



Sir,

This is to submit that Shri Late Nehlenlal Chongloi S/o Shri Thangkhopao Chongloi of Khunkho- Kuki Village, Saitu Gamphazol Block, Kangpokpi District, Manipur was shot dead in the head on 29<sup>th</sup> May, 2023 in L. Tangnuam Village, PO Moulding, PS- Gamnom Saparmeina by suspected valley based militants.

In this connection, GD entry in PS- Leimakhong on 29<sup>th</sup> May, 2023 is enclosed for ready reference as Annexure- A.

Also, Death Certificate issued by Department of Health, Govt. of Manipur, Kangpokpi PHC bearing Registration No. 12/ 23 dated 19/01/2023 is enclosed as Annexure- B.

It is further stated that FIR could not be lodged on time due to high tension which had prevailed in the 1<sup>st</sup> month of the on-going ethnic conflict in the state. The mortal remains of the deceased was buried on 29<sup>th</sup> May, 2023 night itself with the consent of the family relatives as any delay could increase the already charged atmosphere on the public of Leimakhong area.


In view of the above, Leimakhong Area Protection Committee (LAPC) hereby urged your good self to issue FIR ex- post facto and provide us a copy of the same to enable the family of the deceased to avail any reliefs permissible from the government at the earliest please.
