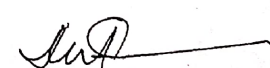

With due regard, I the undersigned have the honour to state a few lines for your kind consideration and needful action.

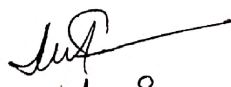
