Today i.e. 25/12/2023 at 5:40 pm, received an information from SP-IW control room that on same day at around 5:30 pm, one two wheeler Vespa White in colour bearing registration number MN01AF-4507 ridden by unknown rider coming from Uripok side towards Iroishemba and one Bajaj Auto Rickshaw, bearing MN04G-5261 driven by unknown driver coming from opposite direction were collided each other in front of Huyam Medical Store, Lamboi Khongnangkhang along UK road due to rash & negligent driving on the part of the unknown driver and rider of both the vehicle . As a result of which the unknown rider of two-wheeler Vespa received injury on her person and evacuated to RAJ Medicity Hospital, North AOC for medical treatment and also both the vehicles got badly damaged.

Hence, a regular Suo-Moto case under FIR No. 2975 (12)2023 LPS u/s 279/338/427-IPC has been registered for investigation.
