With due respect and humble submission, I would like to report that I Ex-Naik N Mamang Gangte of 3<sup>rd</sup> Battalion The Assam Regiment Husband of Mrs.Ramthienghlim who is a Staff Nurse of RIMS Hospital, posted in Imphal, Manipur. After retirement I am residing with my family in Govt. Quarter bearing Quarter No. Type II A 66, Lamphelpat, Imphal West, Manipur (under Lamphel Police Station, Pin – 795004). In the month of May, 2023, I came to Guwahati along with my families for reasons of safety and security due to the turmoil in Manipur at present.

During our absence some of the locality inform us that our Govt, Quarter bearing Quarter No. Type II A - 66 Lamphel, Imphal West, Manipur. The Lock was broken and forcefully occupying the Quarter by unknown miscreants and household goods were stolen and used against our will during the month of July/August 2023 (exact time not known) The approximate value of household goods is about Rs.15 Lakhs and our Car registration No.- MN06L 1540, Model - Maruti Alto K 10 VXI, Colour - MG GREY, Chassis No.- MA3EADE1S00560335, Engine No.- K10BN7361156 was also stolen from my garage.

In this regard, I humbly request you, to register a case and take necessary legal action as

per law.
