Cannot file it at Manipur because of the riot, fear of life and safety. So, I am filing a Zero FIR.

Dear Sir/Madam

My name is Eunice Haokip and I am native of Thinghangphai Village, Chandel District in Manipur. I am currently residing in Vaiphei Enclave, Langol Housing complex, Imphal west, Manipur-795004. I am lodging this complaint against the uncontrolled goons from the Meitei agitators for attempt to murder, looting and burning of my house, properties and valuable items and documents. These heinous crimes have left me in trauma and unsafe in our own state of Manipur.

The incident took place on 04/05/2003 at 4:00pm near Vaiphei Enclave, Langol Housing Complex, Imphal west, Manipur. These miscreants came to attack me and my family with arms and weapons at the above stated time and location. P.S → Lamphel Police station, Imphal West Pin - 795004
 My house was subjected to a horrific act of vandalism, where miscreants of the Meitei agitators which hold the majority of the population broke into my property and looted all our valuable possessions and burnt down my house into ashes. The perpetrators also caused extensive damage and rendering it inhabitable. This has not only caused financial loss, but also emotional trauma for me and my family and the loss will not be able to recover for the rest of my life. Now, I am left with nothing as I had to run for my life and had a narrow escape from death. This horrific incident has had a profound impact on our lives, and we feel violated and unsafe in our homes and I hold the authorities responsible for not providing adequate security measures to prevent such gruesome attacks from occurring.

I urge you to take swift actions to bring these criminals to justice. I request that you launch a thorough investigation into the matter and bring the culprits to book.

I request you to take this matter seriously and to act swiftly to ensure that justice is served.
