Sir.

I would like to submit that during the ethnic riots which occurred at Imphal from the 3rd May, 2023 onward, a large group of rioters/miscreants belonging to the Meitei community ransacked my fast food shop, 'Nanai Eatery', located at the Lamphelpat Supermarket, during daytime on the 4th May, 2023. The mob broke open the shutter of the shop, took out the furniture and other items and burned them in front of the shop. They also removed and stole all other items such as refrigerator, freezer, gas stoves, steel furniture, etc., which would of use to them. No item remains in the shop.

I am attaching the list of items of the shop which were burnt, damaged or stolen along with the assessed costs. The total cost of damaged/lost properties is assessed to be Rs. 6,23,072.00 (Rupees six lakhs twenty three thousand seventy two only).

I am also attaching a photo of the burnt properties in front of the shop.

I was confined to my house as New Checkon Road, Imphal, during the riots due to the curfe v imposed by the State Government and also due the unsafe atmosphere. I have since left Imphal (on 7th May, 2023) and I am now staying at Aizawl for my safety.

I would like to request you to have an FIR registered against those responsible for the damage/loss of properties of the shop to bring them to book and also to recover the stolen goods. I may please be informed the FIR No. once it is registered.
