Sir,

I have the honour to state the following few lines for favour of kind perusal and necessary action.

That, I am writing to formally lodge a First Information Report (FIR) into the unfortunate incident that occurred at my residential quarter in National Games Village, Imphal.

That, in between 5th May to 12th May, 2023 during the height of the ethnic clash, my residential quarter at DGP pool, Quarter No. B-292, Zone-2, National Games Village, Lamphelpat, Imphal-West was targeted and completely looted by unknown miscreants. During this volatile period, I was away at my relative's place in Neikanlong, Thangmeiband, Imphal, as a precautionary measure due to the escalating ethnic tensions. Upon returning on the 13th of May, 2023, I was devastated to discover that my house had been forcibly entered with the main door left open and all our possessions mercilessly plundered.

Although deeply disturbed by this unfortunate event, I refrained from filing a complaint immediately, opting to wait for a more opportune time when the situation would be conducive for proper inquiry. I am now seeking your urgent assistance to register this FIR and initiate a thorough inquiry into this egregious act of burglary.
