No. CET/101/2013/1456 Dt. 13.12.13 namely Mr. Rolland Raisun S/o Lalzaeliun Raisun a resident of Patpuithum village Vangai Churachandpur District, Manipur previously resident at Lamphel near Rajya Sainik Board.

Respected Sir,

With due respect, I the undersigned would like to state the following few lines for your kind consideration and swift legal action against the above mentioned accused person.

That, I am the legal married wife of Late Ahongshangbam Brojen Singh of Ningombam Awang Leikai, Imphal West Manipur who expired on 16/12/2022.

That, starting from 5th January, 2020, the above noted accused person hire a JCB Excavator b/regd. No. MN01AA-2441, Engine no. H00203130 & Chassis no. HAR3DXSUT02716644 from my husband for use in Churachandpur and the said JCB had been taken by him at his residence located at Lamphel near Rajya Sainik Board. Thereafter, the accused person transfer the hiring charges of the JCB Excavator on my husband Axis Bank account having account no. 91802008831180 IFSC Code: UTIB00000657. The accused person sometimes also uses to pay the hiring charges at his resident located at Lamphel near Rajya Sainik Board, Imphal West

Those, after the sudden death of my husband, accused person also transfer the hiring charges of JCB Excavator to my account number 922010059006158 on 22nd Feb 2023 and 8th March 2023.

That, from 03/05/2023 on starting the conflict between KUKI and MEITEI the accused person didn't stay at his resident at Sana Keithel, Lamphel Imphal West. I use to contact the accused person through his mobile phone 9436236270 only.

That, taking chances of the on-going conflict between Kuki and Meitei, the accused person stops paying the hiring charges of the JCB Excavator.

That, even after my several requests to return back the JCB Excavator as he had stop paying the hiring, the accused person didn't listen to me and threatened me to kill if I call him again. He also invited me to Churachandpur and collects the JCB Excavator if I want to die. The JCB Excavator is worth about Rs, 60,00,000/- (in words Sixty lakhs Rupees.)

Respected Sir is kindly requested to register a FIR case against the accused person and recovered the JCB Excavator. Respected sir is also requested kindly to freeze all is contractor account numbers and any work bill to be encase in the near future unless and until he hand over my JCB Excavator. I will be eagerly waiting for your swift legal action.
