Respected Sir,

We are the residents of the above address since
3 years in a Government Quarter.

On the night of the 3rd May, 2023, we came to
know that the Kuki Christian Church at National
Games Village was burnt in the evening. We
collected our certificates and laptop as soon as
possible, and took refuge with our Meitei
neighbours. My son, my daughter-in-law,

my grandson, my daughter and I spend the night there. When it was morning on the 4th of May, 2023 we made our way back where we immediately noticed a red mark on our gate. Alarmed, we drove to the nearest Army camp near D.C. Office around 7 am. We did not encounter any of the Meitei miscreants on the way. The Army, CRPF provided food and drink for everyone who ran for shelter. We also received mats for sleeping. We spend 8 days in the camp from 4th May to 11th May, 2023. On the 11th, we managed to fly to Guwahati and then made our way to Shillong where we are living with our relatives, the MELC Shillong Pastor. We made provisions to drop our car Vigo MNO1AG5519 with our Meitei Muslim friend and he drove it to my daughter's family at Churachandpur. We also came to know our quarter was vandalised and our household appliances, our furniture, gadgets, etc. were stolen and destroyed. The estimate of financial loss stands at Rs. 4,99,200/- . Our emotional loss is unimaginable.

Since that incident, I have not been emotionally and physical sound of health. I have been prescribed medication for insomnia, anxiety and fatigue. Hence, we request you to restore normalcy and punish the perpetrators of the crimes. I no longer feel safe to return to Imphal and want / require compensation of the loss incurred so that we can start over in a safer location, as we are hoping for justice.
