

Respected Sir,

I and my family are living in the above address for the past six years. On 3rd May our house was attacked so we had no choice but to flee we our house the next day on date 04/05/2023 after we left our house we learned that our house has been vandalised by the Meitei Leepun mobs and Arambai Tengol and Meetei mobs. We were shifted to Army camp leimakhong, and then move to multiple places and then finally to Shillong.

I know that my house was vandalsied because we belong to the Kuki tribe. Due to the attack I have lost my material possessions worth Rs. 4,00,000/- and my vehicle Activa worth Rs. 80,000/-. My husband is serving in the Army in Himachel Pradesh and I have 2 children of which one was doing his schooling. Since we moved out, he is unable to continue his education.

Due to the displacement, me and my family have gone through terrible losses financially and are suffering from mental trauma and are left with no hope right now.

Hence, we request you to restore the situation to normalcy and help make good the financial losses we have faced and also help us to go back safely to our house and reside there peacefully and also ensure that there is no encroachment in our absence.

We are hoping for justice for us and all our people from this situation.
