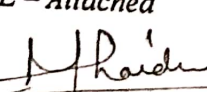

Respected Sir,

I and my family were residing in the above address since January of 2000. On the 4th of May, 2023 we were ordered to move out of the house by the Brambai Jenggel miscreants or else they threatened that they would kill us. Hence we moved with the protection of Central Reserve Police Force (CRPF) to 143 Battalion near DC office Lamphelpat, Imphal west. 795004. On the 14th of May we flew to Shillong. Once we moved out of our house (which is government quarter), they looted all of our belonging by Mitei Miscreants.

My family had to flee the state out of fear for a life as we belong to the Kuki Tribe. We had possessions including electronics, jewels, furnitures, clothes & dresses and various other household material worth Rs. 30,697,500 (3 crore 69 lac 7500 approx) in our house which has all been looted and destroyed, and also our house plot in our locality which basically is a lost property as we will never be able to build on it in the near future.

Due to this incident I and my family have been put to great hardship and mental Trauma. Hence, I request that you will investigate the matter and take proper action against the perpetrators as well as restore the situation to normalcy. ^

We are hoping for justice for all who are in this plight.
