Respected Sir,

I am resident of the above address since 2006. On 4th May, Meitei mobs attacked our locality, and started looting houses. We were so afraid that we moved to the nearby refugee camp. Later on 10th May while I was in the refugee camp I got a call from my friend that our house has been looted and the miscreants took all our belongings with them. We were given some foods by the Army which could barely feed our hunger and the life we live were so miserable. We stayed there till 11th May 2023 and we came to Guwahati. From there we moved to Shillong by road.

I was targeted because I am from Hmar Community and a Christian. Presently I don't feel safe about going back to my home because there is no safer place to take shelter and our life is at stake. I have lost all my house hold belongings worth Rupees 15 lacs. {Furniture like Bed, Sofa set, 3 Steel Almirah, 1 Wooden Almirah, 2 Dressing Tables, TV wooden set, Dining Table set, 4 Ceiling Fan Home appliances like Fridge, TV, Gas Stove, 4 cylinders, 7 Water Container Tank, Microwave Owen, Utensils, TVS Ntorq 125 CC. etc.

Kindly ensure that we get compensation for all our financial loss and provide security for future. We are hoping for justice for us and all our people from this situation.
