Meetei Leepun in Zone-I and we even heard from our relative staying in Zone-iv that they were

being attacked by the Arambai Tenggol and Meetei Leepun. We were terrified thinking that we

may died but luckily we manage to escape and rush to 143 CRPF Camp Lamphel the next day i.e

the 4th of may, and stay there till the 10th of May and on the same day we were escorted by the

CRPF to Imphal Airport for Guwahati and stay there for aday and then left for Shillong on the 12th

of may 2023, And currently we are taking a temporary settlement at Lapalang Shillong.

It was clear that the Meitei mob had attacked us with the help of Arambai Tenggol merely because

we are non-naga tribal Christians. I am a Government Employee working as UDC in SCERT

All our household items, washing machine, refrigerator, sofa set, 4 almirahs, bed sets, dining set,

clothes, wardrobe, are all lost. The mental trauma has been deep and agonizing as any sound

triggers panic attack and sleepless nights follow me to this day.

There is no way we can continue to reside with the valley(Meitei) people in the valley. And we

can not go back to Imphal Valley as the hatred and brutality towards the Kuki-Zo Community is

so immense. So, the only solution is separate administration so that the people in hills and valley

can reside as neighbouring communities.

Hence, we request you to restore normalcy and punish the perpetrators of these crimes and provide

us a new home where we can feel safe and secure, as we are hoping for justice.
