Date of incident: 4th May 2023

Respected Sir.

I am an engineer by profession and serving the Government of India as Sr. Manager at NTPC Ltd, Chennai and I belong to the Kuki community. My family have been residing at the above captioned address for the last 10 years. On 4th May 2023, around (10:00 am), a large mob comprising of members of Arambai Tenggol, armed with weapons such as knives, iron rods. stones, bamboo sticks, etc. rained down on my family and threatened them to leave the house else they would kill them. Helpless and in fear, they moved out of our house, with only the clothes they wore, leaving behind all our belongings. The Police commandos then took them to 1st Manipur Rifles Headquarters. The next day, with the help of relatives, they fied to Shillong. On the same day, we came to know through our neighbours that, our house, along with all belongings and the vehicles parked inside the compound were burnt down by the

The conservative estimation of my house is ₹. 90,00,000/- (Ninety Lakhs only). Along with the house, there were ₹ 50,00,000 (Rupees Fifty Lakh) worth of furniture and fixtures including vehicles, jewellery and other miscellaneous household items burnt down to cinders. The pictures after the mob violence indicates that there is nothing left that could be salvaged after the burning

Needless to say, this house and the belongings therein are all that I have, which was acquired from my hard-earned savings over the years. Due to this incident, I and my family are rendered 'homeless' putting us to great hardship and mental trauma.

My family, had to flee for safety as we are from Kuki community. Needless to say, we still fear for our life. I don't know when we can go back to Imphal.

It is in these circumstances that I request you to investigate the matter and take proper action against the perpetrators, restore the situation to normalcy, and provide protection for our properties and the whole locality from encroachment. FIR is not possible to file in person due to unsafe situation. I have forwarded my FIR copy by post.

I and my family, as victims of this unjust violence, hope for justice for us and also for all those
