I am a doctor by profession and serving the Government of Manipur as Deputy Director at Medical Directorate, Imphal and I belong to the Kuki community. I and my family have been residing at the above captioned address for the last 15 years. On 4<sup>th</sup> May 2023, around ( 10:00 am ), a large mob comprising of members of Arambai Tenggoi, armed with weapons such as knives, iron rods, stones, bamboo sticks, etc. rained down on us and threatened us to leave the house else they would kill us. Helpless and in fear, we moved out of our house, with only the clothes we wore, leaving behind all our belongings. The Police commands then took us to 1<sup>st</sup> Manipur Rifles Headquarters. The next day, with the help of relatives, we fled to Shillong. On the same day, we came to know through our neighbours that, our house, along with all belongings and the vehicles parked inside the compound were burnt down by the unruly mob.

The conservative estimation of my three storey house is ₹. 3,50,00,000/- (Rupees Three Crore and Fifty Lakhs only). Along with the house, there were ₹ 80,00,000 (Rupees Eighty Lakh) worth of furniture and fixtures including home gym and vehicles, and ₹ 10,00,000 (Rupees ten Lakh) worth of jewellery and other miscellaneous household items burnt down to cinders. The pictures after the mob violence indicates that there is nothing left that could be salvaged after the burning of my house by the mob.


Needless to say, this house and the belongings therein are all that I have, which was acquired from my hard-earned savings over the years. Due to this incident, I and my family are rendered 'homeless' putting us to great hardship and mental trauma.

I, along with my family, had to flee for safety as we are from Kuki community. Needless to say, we still fear for our life. I don't know when we can go back to Imphal for duty or if my salary will continue to be paid.

It is in these circumstances that I request you to investigate the matter and take proper action against the perpetrators, restore the situation to normalcy, and provide protection for our properties and the whole locality from encroachment. FIR is not possible to file in person due to unsafe situation. I have forwarded my FIR copy by post.

I and my family, as victims of this unjust violence, hope for justice for us and also for all those who are in similar situation.
