Respected sir/ma'am

We are the residents of the above address since 2000 jan till this date. On the night of 3rd may around 7:00 pm Meitei mobs who we believe are the Meitei Arambai tengol and the Meitei leepun along with the locality Meitei's who are known to us forcefully entered our house and started attacking us. Some of them were armed with guns and knives and all sort of things. I hide my 5 children under the bed because I was scared for their lives. Scared the mob would kill us. After awhile we hide around our house tunnels waiting for them to move out. The next morning the CRPF came to escort us out. And we were move to the relief camp. They destroyed all our belongings and looted all of them once we move out and after that they burned down our house.

Around 4-5 k people stayed together in the CRPF camp with limited foods and waters . we stayed for 4-5 days and with the help of my eldest daughter who works in Bangalore we manage to reach Shillong and stayed in my distant relatives for awhile and later again move to another place. On the 6th may we spent a day sleeping in the airport along with my children. And on the 7th may we left Manipur.

We believe we were attacked solely because we belong to kuki community. Because the mob shouted and chanted (Nangkhoi asi da lei ba yararoi) meaning when translated (you people cannot stay and reside here any longer)

I am a widow who solely relies on my late husband pension money. I have no other sources and now all my documents have been burned down along with the house.

The amount of properties that have been damaged and lost is worth upto Rs 18,000,0000.

Valuable/jewels/ cash – 80000000, Electronic appliances – Rs 22000000,

Vehicles-25000 and household appliances worth 101000000.

This mayhem which is cause by the Meitei arambai tangol and the Meitei leepun have cause me a lot . I have suffered from PTSD along with palpitations after the attack. Always tense and fearful whenever I heard a loud noise from afar.

Hence, I asked the higher authority to compensate me for my lost and bring justice for me and my family. And to book the culprits as per section of the law.
