

Respected sir/mam,

We are the residents of the above address for the past 11 years and on 4th may when the incident escalated Meitei miscreant vandalize and looted our properties. We had no choice but to leave the place. We moved to CRPC camp near DC office Imphal west, and stay there for 6 days without any belongings in our hand. and on date 9, with the help of our friends from outside Manipur an air ticket was arranged and along with my families we reach Shillong on date 10th may through Calcutta via Guwahati.

We belong to the kuki community and due to the unrest there is hatred towards me and my family and we are being targeted. The amount of property that has been vandalized and looted is worth Rs.9 lakhs.

Two wheelers vehicles worth Rs.2.50 lakhs,
Music instrument 2 piano, 1 guitar worth Rs.1.50 lakhs.
Furniture worth- 5Almirah worth of Rs 5 lakhs, 4 Bed – Rs-1 lakh.
Electronic devices- Rs 2.50 lakhs. My wife traditional attire which is worth a fortune of 1 lakh.

I serve in Manipur police department and now due to this displacement I am unable to report for work for the fear of my life and my family lives, I have two daughter and one son.

Due to the displacement, me and my family have gone through terrible losses financially and are suffering from mental trauma and are left with no hope.

- Kindly, give us protection and take legal action against the perpetrator who have vandalized my house.
